

## **HEAVY INDUSTRIAL (HI) DISTRICT**

### ***Purpose and Intent:***

The HI, Heavy Industrial District is primarily intended to accommodate a wide range of assembling, fabricating, and manufacturing activities. The district is established for the purpose of providing appropriate locations and development regulations for uses which may have significant environmental impacts or require special measures to ensure compatibility with adjoining properties.

### ***Additional Requirements:***

All permitted uses within the Heavy Industrial (HI) District shall be served by public water and sewer, unless the Enforcement Officer determines that it is not available and not required.

## HEAVY INDUSTRIAL DISTRICT

### *DIMENSIONAL REQUIREMENTS FOR NON-RESIDENTIAL HI DISTRICT USES:*

<i>Minimum Lot Size</i>	<b>30,000 square feet</b> , [ <i>Lots of Record having less than minimum required area may be developed pursuant to Section 9-4-17(a) (Nonconforming Lots Record). Smaller lots are permitted for residential uses (refer to Tables 4-11-3 and 4-11-4).</i> ]
<i>Minimum Lot Width</i>	<b>100 feet</b>
<i>Minimum Street Frontage:</i>	<b>75 feet</b>
<i>Minimum Street Setback:</i>	<i>Setbacks along private streets shall be the same as along local streets. Setbacks from common private driveways are regulated by Section 9-4-11(b)(4)b.2. Setbacks may be reduced in accordance with Section 9-4-12(b).</i>
Local, Subcollector, & Collector	<b>25 feet</b> from the property line or <b>50 feet</b> from the centerline of the street whichever is greater
Minor Thoroughfare	<b>30 feet</b> from the property line or <b>65 feet</b> from the centerline of the street whichever is greater
Major Thoroughfare	<b>35 feet</b> from the property line or <b>80 feet</b> from the centerline of the street whichever is greater
<i>Minimum Interior Setbacks:</i> <i>(side &amp; rear yards)</i> Adj. to Non-Residential Zoning <i>Minimum</i>	<b>0/5 feet</b> , (Zero setback if no setback is provided. If setback is provided it must be a minimum of five (5) feet.)
Adj. to Residential Zoning	<b>50 feet</b>
<i>Maximum Height:</i>	<b>50/80 feet</b> (50 foot maximum height without additional setbacks. Increase all setbacks by one (1) foot for every one (1) foot increase in height between fifty (50) and eighty (80) feet, but not to exceed eighty (80) feet in height.)
<i>Maximum Building Cover (% of Lot)</i>	<b>60 percent</b> of lot

Notes for residential development:

- A minimum of sixty percent (60%) of the frontage between two (2) intersecting streets on the side of the street in question must be developed as residences for additional single family development to occur.
- All dwellings and accessory structures shall be subject to the development standards of the Residential Single-Family-7 (RS-7) District.
